The objectives of the James N. Kirby Foundation have been formulated on a broad charitable and community welfare basis. The Foundation's overall goal is to distribute grants to charitable, educational and technical bodies throughout Australia in the areas of health, education, technology and science, art, literature, the environment, conservation, maintenance and development of Australia's natural resources, with particular attention being given to technical education projects to assist young Australians achieve their highest standards.



The logo for the James N. Kirby Foundation was derived from the armorial bearing designed for Sir James when he received his Knighthood in 1962, and is seen in its entirety here. Sir James wished to incorporate an Australian theme alongside references to his love of fishing and manufacturing, as well as his interest in nuclear energy.

The final design shows a Marlin rising from the waves and incorporates references to manufacturing in the form of two Millrinds (a heraldic representation of support unit stands for grinding wheels) plus nuclear energy through two atoms of Helium circling in their elliptical paths. The Australian element is revealed through the incorporation of a boomerang above the words "Ngaben Bidjigarme" - an aboriginal expression in the Arnhem Land language, still spoken today. It literally translates as "I all hands hold" the nearest meaning to "I serve all".

As we enter the 42nd year of the James N. Kirby Foundation it gives me the greatest of pleasure to present the Chairman's Report for 2009. Since the Foundations inception we have donated nearly 13 million dollars to causes in medical and research, education, the environment, social welfare and art. We currently average 1 million dollars in grants being paid each year.

Over the years support has been given to many organisations and it is certainly heartening to visit recipients and to receive the various progress reports which illustrate the benefits the donations provide. One such organisation visited this year was The Infants' Home, Child and Family Services at Ashfield. The Foundation supported the 'Sydney Hope Family Cottage' at The Infants' Home which is a day stay and home visiting service. The purpose of the grant was to provide 10 families who have complex problems and family vulnerabilities with sustained home visiting. Another organisation the Foundation has supported over the years is The Indigenous Australian Engineering Summer School which aims to encourage Indigenous young Australians to consider careers as Engineers. In January I had the pleasure of attending the Summer School's presentation of Awards and I was honoured to receive on behalf of the James N. Kirby Foundation an Aboriginal Message Stick in appreciation of the Foundation's support.

The audited financial statements of the Foundation for the year ended 30 June 2009 are presented in this Annual Report and in the opinion of the Directors of the Trustee, these statements are properly drawn up so as to give a true and fair view of the state of affairs of the Foundation and its results for the year ended on that date, and are in accordance with applicable Accounting Standards and the Trust Deed dated 17 October 1967.

The Foundation's gross income for the year ended 30 June 2009 was \$1,530,840 (2008 \$1,718,059) including donations received of \$630,000 (2008 \$500,150) with \$997,300 (2008 \$1,100,500) paid in grants during the year.

Since its inception in 1967, grants and donations totalling \$12,780,402 (2007/2008 \$11,783,102) have been made by the Foundation. These fall into the following categories:

During the year, the Foundation approved grants totalling \$1,042,800 allocated for payment as follows:

Consideration is only given to applications that fully comply with the requirements for applications and are accompanied by the Australian Taxation Office's Endorsement as a Deductible Gift Recipient. The contents of that letter should also confirm the status of the organisation as falling under Item 1 of the table in Section 30-15 of the Income Tax Assessment Act 1997.

The many reports received from recipients of financial assistance, letters of thanks and progress reports in regard to the various projects undertaken, together with special acknowledgments such as plaques and certificates of recognition and appreciation are always greatly appreciated.

In accordance with the Articles of the Trustee Company, Emeritus Professor Christine E Deer, Emeritus Professor Sir Rupert Myers KBE AO FTSE FAA, Dr Brian W Scott AO and Mr David W Smithers AM retire as Directors of the company but being eligible have offered themselves for re-election at the trustee company's Annual General Meeting.

I acknowledge and extend my sincere thanks and appreciation to the Directors for their guidance and assistance in allocating the income of the Foundation as a great deal of analysis is required to properly evaluate requests that are received. We also appreciate the continued contributions made by our honorary solicitor, Mr Ken Ramsay and our honorary auditor, Mr Alan Neilson.

# Improving literacy skills amongst indigenous young people

With the support of the James N. Kirby Foundation, the Aboriginal Literacy Foundation was able to launch a new literacy tutoring project in the North West region of Victoria. The project has been a wonderful success. With this funding support we were able to recruit and train 4 volunteer tutors to work with 55 indigenous students.

The literacy tutoring program was designed for the most disadvantaged, marginalized and isolated indigenous children experiencing major learning difficulties. The service is mainly delivered by volunteer school teachers who act as tutors to the children. At a crucial time in a child's life, the program acts as a unique "stepping stone" into improved literacy and life skills.

We are pleased to note that we had a 82% retention of the students throughout the program and saw some

excellent individual literacy gains. Other important outcomes were an improvement in the student's self-worth and confidence and greater community participation and positive involvement with peers and family.

# Dedicated to the alleviation of asthma



PARENTS, BABIES AND CHILDREN'S EXPO

The Asthma Foundation of Western Australia is a community based, non-profit organisation dedicated to the alleviation of asthma as a cause of morbidity and mortality in our community. The Foundation has a range of educational and support services to help people with asthma, along with their carers. The Asthma Foundation of WA is also home to various important projects including the Newborns Asthma Parental Smoking (NAPS) Project, Asthma Friendly Schools project, Adult Asthma Swim and the Triple E program for school aged children.

The NAPS Project promotes the message "Care for my air!" and encourages pregnant women, new mothers and their families to protect the foetus and newborn from passive smoke. Currently 17.1% of women in

Australia smoke during pregnancy. Exposure to tobacco smoke whilst pregnant can increase the risk of asthma, Sudden Infant Death Syndrome (SIDS), the baby being born an unhealthy birth weight, miscarriage or premature labour, perinatal mortality, difficult births and a higher risk of ectopic pregnancy.

The \$10,000 received from the James N. Kirby Foundation has enabled the project to purchase a variety of resources that promotes the "Care for my air!" message.

The (NAPS) Project attended the Parents, Babies and Children's Expo for 3 days in August. Whilst our display received strong, positive feedback, it was the "Care for my air!" packs, along with baby's bibs displaying the message "Care for my air!" that proved to be very popular.

The Asthma Foundation of WA would like to thank the James N. Kirby Foundation, whose generous donation and support of the Newborns' Asthma Parental Smoking Project has enabled the project to continue to help pregnant mothers to quit smoking to help reduce the risk of the baby developing asthma, Sudden Infant Death Syndrome or being born an unhealthy birth weight.

#### Black Dog Institute

# Help for rural communities

Support from the James N. Kirby Foundation has opened the door for the Black Dog Institute to embark on a program with the message 'Let's Talk About Depression' in rural New South Wales.

The program is designed to break the silence and encourage rural communities to talk about mood disorders; especially in view of recent evidence showing that Australians impacted by drought are twice as likely to have a mental health issue if they are directly affected.

The Black Dog Institute is based at the Prince of Wales Hospital in Sydney. It is a not-for-profit educational, research, clinical and community-orientated facility offering specialist expertise in depression and bipolar disorder.



**REACHING THE RURAL COMMUNITIES** 

The Institute has observed distinct evidence of the strain on rural and remote communities caused by the nature of life in those areas, including isolation and drought, as well as social and financial pressures.

Determined to improve the understanding, assessment and management of mood disorders in these areas, the Institute has embarked on an ambitious program with the financial support of The James N. Kirby Foundation. Building on work commenced in 2008, such support allows the Institute to expand the program in 2009 with events in rural NSW locations such as Orange, Moree, Gunnedah, Griffith, Condoblin, Forbes, Singleton, Dubbo, Armidale and Quirindi.

The rural strategy encapsulates the range of services provided by the Institute, including community education and support, clinical services, education and training for health professionals, information and education modules on the Institute's website, and through community programs.

# The gift of dance for disadvantaged kids

In January this year we received your cheque for \$6,000.00 for our "Gift of Dance" program for disadvantaged children. Three of our ten students are about to do their level seven exams which will allow them to become assistant teachers. They were the first students to go onto the program. They came to our attention when we began taking students from the local primary school, for dance classes. As they would not join in the school's sport program the students involved caused problems for the teachers as they were left to amuse themselves in class while the rest of the school did sport.

After talking to the school liaison teacher we came upon the idea of taking the students for dance classes as our studio was just down the road and they could walk to it. The liaison teacher accompanied them. At first things

didn't go too well but eventually they settled in and the teacher remarked on the improvement they were making in their behaviour in school classes.

The three students who are now about to do their level 7 exams started to ask if they could come to regular dance classes. After talking to the liaison teacher she informed us that their families would never be able to afford the classes even though our fees are kept to a minimum. So we decided to start the "Gift of Dance" program. These three students have made us very proud. They are all now at high school and have become lovely well mannered teenagers. This October they will be part of a group of other students on the program who will compete in Toowoomba's Youth Ballet competitions. If it wasn't for the help of the Kirby Foundation then I don't think we could have continued with the program. *It makes me feel so great to see the difference that dance can do for children who otherwise may have gone astray.*

Fathers and Sons on the YoungStars Program

Pathways believes it is vital that good parenting and healthy self esteem go hand in hand and should be implemented in the formative, early years of our children's lives to ensure our youth remain positive about their future and achieve to their highest abilities.

Thanks to the strong support of the James N. Kirby Foundation, 2009 marks a significant year of growth for Pathways and in particular *YoungStars*...our weekend program for fathers and sons aged 6-10.

The aims of YoungStars are to:

- encourage fathers to be active, rather than absent, in their son's life;
- celebrate fatherhood; and
- teach and encourage self esteem in children from an early age.

With the James N. Kirby Foundation's support, the *YoungStars* program now serves a much broader cross section of participants in regional areas and includes a stronger emphasis on parent education. We will deliver up to 10 *YoungStars* programs by the end of 2009 and aim to reach new *YoungStars* in South East QLD, Tasmania, Western Australia, mid-North Coast NSW and North Coast NSW.

YoungStars has achieved many additional milestones thanks to the James N. Kirby Foundation's support, namely:

- The creation of a revamped YoungStars training manual;
- Specific YoungStars leadership training programs delivered to all Program Leaders;
- A strong relationship created with Centacare in Dubbo with plans to roll out a *YoungStars* program there or in Forbes before the year's end; and
- The completion of the first ever YoungStars brochure which will help enormously as a marketing tool.

The Pathways Foundation greatly appreciates the James N. Kirby Foundation's support in partnering with us to make large scale social change to Australia's youth.

# Myoelectric prosthesis is a state-of-the-art artifical arm

Established in 1984 with the vital and ongoing support of Variety, the Children's Charity (NSW), the Limb Deficiency Clinic at The Children's Hospital at Westmead runs a Myoelectric prosthetic clinic for children with congenital deficiencies, or amputations of their forearm and hand.

A Myoelectric prosthesis is a state-of-the-art artificial arm where the electromyographic (EMG) signal generated by a contracting muscle can be detected by surface electrodes and used to control the opening and closing of an electric hand. Myoelectric prostheses have become an internationally accepted standard in the treatment of paediatric upper limb deficiencies. The number of children with such disabilities is few, and as such there is only a small number of experienced therapists in this area within Australia and overseas.

The current cost of a Myoelectric arm is \$12,000 and young children will generally outgrow their prosthesis within 12 months. Through the ongoing support of the program by Variety, the Children's Charity (NSW), the hospital is able to provide prosthetic limbs free of charge to families. Funding allows the hospital to purchase a variety of hand sizes, with these electric hands then being reused when the child has grown into the next size.

The very generous gift of \$10,000 from the James N. Kirby Foundation to Variety during 2009 has ensured a child received a brand new Myoelectric arm earlier this year.

## Transition to trade



Developing Skills through Specialised Programs

Yooralla is Victoria's oldest and largest not for profit community service provider's. We actively support people with disabilities, their families and carers to live the life they choose.

Earlier this year, we were the recipients of a James N. Kirby Foundation grant of \$20,000 which has enabled our First Base Leongatha service to run a life enhancing project for young people with disabilities.

Yooralla's First Base service supports young adults with a disability to make the transition from school years to adulthood by developing skills and achieving individual goals through specialised programs.

Many young people with disabilities are denied the opportunities other young people have of finding work in a trade. They may lack work readiness skills and a

real understanding of the workplace environment. A further challenge is that many employers focus on their disability rather than their potential.

The idea behind the project is to allow young people with disabilities to trial a trade at their own pace. Then if they express an interest in pursuing that work they can be further supported to gain employment. The project also provides opportunities for employers to realise the potential employability of people with disabilities.

The very generous support of the James N. Kirby Foundation has enabled us to conduct introductory courses in carpentry. The trainees are not only developing their skills in a trade, they are also experiencing what it is really like to work in that trade and further developing their work readiness. This all adds to their self esteem, raises their awareness of work options and expands their social and employment contacts. It is a big step on the road to gainful employment.

  - (b) The application will be rejected if the applicant is not endorsed as a Deductible Gift Recipient or has tax deductible status under Item 2 of the table in Section 30-15 of the Income Tax Assessment Act 1997.
- 2. The Foundation is not empowered to assist individuals.
- 3. The Foundation does not assist projects or entities outside Australia.
- 4. Grants are assessed on their proximity to the stated objectives above.

GRANTS MADE AND CONTINUANCE OF ANNUAL FUNDING ARE SUBJECT TO

- i. the recipient retaining tax status as a Deductible Gift Recipient
- ii. funds being applied specifically for the purposes as outlined in the original application
- iii. recipients providing a report annually as to how the funds have been applied, and
